# **REPORT ON PROJECT "SAHAI"**

Date: 29<sup>th</sup> September, 2021

The Report on the our project "SAHAI" for the victims of Boat Tragedy of Nimati ghat on 8<sup>th</sup> September, 2021, the Biggest Boat Accident at Nimati Ghat of Jorhat District of Assam where more than 140 people were effected out of which officially 88 persons were recovered and 3 dead bodies were recovered. But, still there are many missing cases but unofficially. We have talked with some of the Nimati victims, were found to be in a TRAUMA of the incident. They are still to be normal in their life.

The report on the "project SOHAI"-a project for supporting by Mental Help through Clinical, Psychological counseling to the Victims of Majuli for Nimati Tragedy on 8<sup>th</sup> September, 2021.

We moved from Guwahati on 19<sup>th</sup> September, evening and booked the Ferry from Nimati Ghat to Majuli on 20<sup>th</sup> Sept, morning. Since the communication to Majuli was interrupted due to the accident. All Single engine boats are been stopped only two Government Ferris were for the inland water communication, therefore, there were rush for tickets. People were making the lines for ticket from early 3.00 Am morning. These all are covered in the news papers and channels. We knew the situation; therefore, we communicated the system and took the help of a Reported to get our tickets.

When we reach Kamalabari Ghat, directly we went to the DC office for the Final communication regarding our Program. Mate the ADC Mr. Bipul Das. But, after some communication we came to know that the administration is not interested on the entire subject i.e. Nimati Accident. As all the news channels were covering against the administration regarding non action to the Nimati Victms.

Once, we got the instinct, we informed our MOTO, and argued that we are not here to take permission, we are here to compare the exact final List of the victims that we have with us to confirm the actual status. We told that we are here to support and heal the Victim's Mental Health not for any kind of Business. As I told that whole media of Majuli is with us for the cause. So, even if you not permit us for the Project we will do it on our own. After this argument, the ADC and DC might had their views, then after 45 minutes they call us again and gave us the entire List of 91 victims in printed format and informed, assured us for any kind of support.

We tried to call all 88 victims that we had in the list informing about the 3 days Mental Health support program at Garmur Press Club, Majuli (three are Dead)

Fortunately, all victims agreed and were excited about the health Camp. Confessed their pain that they had for the accident. We found maximum who were in a Trauma.

We opened our "Mental Health Treatment Camp" SAHAI at 11.00 AM to 2.00 PM. every Day. Where Psychiatrist Dr. Siddhart Sahu, Clinical Psychologist Ms. Himashree Chaudhuri and Psychotherapist Ms. Neena Sharma, Counseled and advised the victims. Some are been prescribed medicines to recover from their Trauma. Our Team members communicated the victims for the mind relaxation.

Out of 88 victims 3 were not in the condition to reach out our camp. We went to their house to treat them along with the Clinical team. (<u>Mamoni Phukan</u> and <u>Priyanka Phukan</u> of Bhakat Chapori a very remote place of Kamalabari, Half way by car and half way on foot. <u>Rakhi Bora Hazarika</u> of Bongaon)

### **Our Findings:**

- 1. Fear and shock during their sleep.
- 2. Always feel that they are still in water.
- 3. Remember the incident and shivering occurs.
- 4. Cannot concentrate at their daily work.
- 5. Head ache.
- 6. Gets angry if somebody asks about the incident.
- 7. Restless.
- 8. Appetite problem.
- 9. Frequently falls in to excessive heat beat.
- 10. Stress.
- 11. Emotional Stress.
- 12. Fear of Water.
- 13. Always dreams about the accident while sleep.
- 14. Flashback problem.
- 15. Depression.
- 16. Loss of Properties (Bike, Business Goods, etc)
- 17. Loss of Finance.
- 18. Not Getting Support from Administration or Govt.

## The views of the Victims:

>>"I cannot sleep at night. As soon as I lie down I feel like drowning in the water and feel difficult to breadth. This is happening last 13 days. Even in the day time also, I cannot sleep. I am tired of fear, please, help me. I want to sleep. Please, give me medicine."

>>"Please! I do not want to remember the incident. It hearts me lot, I lost my byke, the only support of my family for our all communication for our small business and lively hood. Since, 8<sup>th</sup> of September, No body from the Government tried to help us, but the called us for all details at DC office."

>> "I was with my kid, we all were drowning. One person saved us. I cannot still believe that I am alive with my only child. Now, when I sleep, in the mid night I get frightened always and weak up to search my child whether he is near me or not."

>> "I got back pain along with my hand pain. I got stuck in the railing near the exit under water. I was about to die. I left all hope. But, the boy, I do not know how he brought me up and saved my life. Yes, Puplu Tide, the boy, I came to know later by others."

>> "First time, when I came out from the boat and jumped to other one, I did not think that the previous boat will be turned upside down. As soon as I reached the other boat, I saw one by one all bykes and goods along with people drowning in the water. First I could not thing what will I do. Unknowingly, I jumped and first I searched my mother, then one by one I saved 5 people."

>> "We are happy, that you are here to help us. We thank God. There are so many NGO's, even Government, DC office. But, no body tried to even ask what we felt or how we are feeling. At least, from this program we got a department at our Hospital."

>> "When I jumped in to the water, I was not in the condition to think what will I do, I just jumped. I even forgot that I cannot swim. The best thing I did I threw my bag. My whole earning of my life. But, how I do not know, Thank God, I am alive. I lost my valuables, I lost my Ethnic Cloths which worth about 3,00,000/- the only business for our survival. May be the water, I got skin dieses, now I have chest pain and breathing problem too. I went to Dibrugarh Medical for Checkup, but still I am not well. Please, help."

>> "Me and my wife both were in the boat that day. With the help of others we saved us. But, the fear of water, we cannot say that. Even in the day time we dream about the incident. She has stopped taking food for the shock. Any time she stays in a depression, never wants to talk with others. Stays silent. I do not know what to do."
